To the Fresno City Council,


As a concerned local artist with autism, I urge you not to support entertainment zones in Fresno. I've shown in several regional and nationally recognized art exhibitions in the Central Valley. However in the recent years, the Fresno ArtHop environment has become less and less accessible.

Especially in Downtown, the focus on local artists has been lost due to monopolizing the proposed "entertainment zones" and enabling irresponsible consumption of alcohol. It is already a public health issue, because there were previous reported incidents of violence that were preventable. We cannot risk the livelihood of our community for the benefit of making profits.

Speaking from the perspective of a disabled brown woman, I don't feel safe navigating ArtHop unless there is reliable public transportation, and it's a controlled environment. Having these entertainment zones are proven as the exact opposite of safe and controlled environments.

Despite Fresno being the 5th largest city in California, reliable public transportation is far from accessible. Why have an entertainment zone in a car-centric city. Logistically, this doesn't make sense.

To whom it may concern-

As a longtime Tower resident, I am vehemently opposed to the City's proposal to add "entertainment zones" for certain downtown events.

The City of fresNo has a long and storied history of actively promoting Certain Business Interests above and beyond the interests and wellbeing of her residents, and this is just one more in a long string of bad ideas.

The City has repeatedly demonstrated that it is unable to provide sufficient supervision for the current levels of alcohol consumption, and inviting more drinking will only worsen the impact.

The violent events at Arthop and more recently in Tower should be a very fresh reminder. The business owners who will be the primary beneficiaries of this new policy may be struggling, but their survival should not come at the expense of actual residents and the other businesses in the area.

Even a best case scenario here will have an incredible negative impact on the people who are not involved and not profiting - traffic, noise, litter, and the regular prevention of the quiet enjoyment every person is legally entitled to have on their own property.

The City already ignores the negative impact that Tower street drinking has on Tower residents and property owners; local government should be protecting all taxpayers and residents instead of allowing a few people to profit at the expense of many, many others.

If the City has decided they are committed to this policy, perhaps they could start by providing proof of concept with a pilot program at a site in north fresNo, and after all the difficulties have been resolved, only then consider possible additional implementations in other parts of the city.

No entertainment zones when the city currently has a long documented historical inability to keep street drinking under control.

Hello, My name is Brian Vasquez. I oppose item number 26-747 and all permits being issued by the city of Fresno. I have several reasons why I oppose this rushed entertainment zone.

1. The downtown area this Entertainment zone is going to be held has seen an increase in violence in and around close proximity to this exact proposed area. I don't think more access to alcohol in and outside these brick and mortar businesses is a good idea. Strangers walking amongst other strangers outside the safety and perceived security while intoxicated invites a nonchalant mood to this area that destroys the family environment.
2. The fact that this EZ was planned with no input from the people in backrooms is a red flag. I find this permit flying through unchallenged with zero transparency until the very end of may, with one post by Downtown Fresno Partnerships instagram page, seriously and intentionally discretionary. And DFP only posted that Ez zone faq because they were getting justified heat from the public. The full intention of this radio silence was planned. The same tactics were used to rush other ez zones in other counties. I think DFP wanted no public input at all.
3. I don't appreciate Property Owners that don't live here, like Nora Monaco, having any input on what permits are approved here. If violence happens, will the landlords take accountability for pushing DFP and the brewery businesses to rush to push this EZ through The council with Almost zero transparency from the public. It was the public that had to inform us. It wasn't DFP nor the businesses. This was intentional discretion and it stinks. We don't want more violence, more rushed permits without a thorough transparency campaign for this new ez.
4. I've heard from brewery business owners that they might be one bad month from closing down. And a business owners admitted that there hasn't even been an approved budget for all of this? Furthermore, the breweries can barely handle the crowd on a regular Arthrop day. And these breweries will have their alcohol license at risk if they have a violent issue happen in their business. What business took that deal? This tells you they are desperate. They have to pay for increased insurance and now these businesses have to pony up backup funds for this event? If this EZ does not hit for these businesses, it's dead anyway.

Vote no on this poorly planned EZ, Fresno City Council. Show your constituents you listen to everyday people, and not just commerce nonprofits, landlords and businesses to the risk of Fresno people.
