A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, AUTHORIZING ACCEPTANCE OF
\$46,242 IN GRANT FUNDING FROM THE STATE OF
CALIFORNIA DEPARTMENT OF PARKS AND
RECREATION FOR THE FRESNO POLICE
DEPARTMENT'S 2019 OFF-HIGHWAY VEHICLE GRANT

WHEREAS, the Fresno Police Department (grant applicant) desires to undertake a project for the education and enforcement of off-highway vehicle related laws and regulations to be funded in part from state grant funds made available through the 2019 Off-Highway Vehicle (OHV) grant program administered by the State of California Department Parks and Recreation; and

WHEREAS, the procedures established by the OHV grant require that, when selected for funding, the grant applicant is to submit a resolution from its governing board authorizing the grant applicant enter into a contract with the State of California (Grant Agreement) and execution of related documents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Chief of Police for the City of Fresno is authorized on its behalf to sign the Grant Agreement, including any extensions or amendments thereof, subject to prior approval as to form by the City Attorney's Office. This authorization extends to amendments that add additional funds to the original contract, subject to approval by this governing body of an amendment to the City's appropriations resolution.

3. The grant funds received hereunder shall not be used to supplant expenditures controlled by this governing body.
