Re: Public Comments regarding Hearing for Mills Act Contract for 3504 E Huntington Blvd

I am writing regarding the Mills Act Contract under consideration for 3504 E. Huntington Blvd. I understand there is a meeting of the Fresno City Historic Preservation Commission scheduled for Oct. 27, 2025. I live in the Huntington Historic District and have concerns regarding preservation of the property under consideration, or even its continued classification as an historic structure.

The house at 3504 E. Huntington has recently undergone significant roof alterations that have destroyed its historic character. Large areas of original roof tiles have been **partially** removed then in-filled with modern asphalt shingles leaving a combination of asphalt bordered by tiles. (Please see photos included with this document below.) This ugly, and inappropriate combination has not only devastated the historic architecture of the building but damaged the nature of the entire historic district. I can't imagine how this arrangement obtained a building permit. Nor should the building be eligible for tax subsidized preservation given its current state and the attitude of the property owners toward historic preservation.

Finally, while I am uncertain as to the relevance to the Mill Act application, it should be noted that 3504 E Huntington is currently listed on AirBnB. I have attached screen shots of the listing.


