SUMMARY

The City of Fresno is an entitlement community receiving Emergency Solution Grant (ESG) funding from the U.S. Department of Housing and Urban Development (HUD). As an entitlement community the City is required to prepare an annual action plan detailing how funds received from HUD will be expended to meet housing and community development goals outlined in the Consolidated Plan.

The 2014-2015 Annual Action Plan was approved by the Fresno City Council on June 19, 2014. The City proposes to substantially amend the FY 2014-2015 Annual Action Plan to include and award prior year ESG funding in the amount of \$400,000 to the following agencies to carry out services for persons that are homeless:

- 1. Marjaree Mason Center Emergency shelter services for battered women and children. ESG – an amount not to exceed \$100,000.
- 2. West Care Rapid rehousing and case management services for persons that are homeless or threatened with homelessness. *ESG an amount not to exceed \$300,000*.

The proposed programs have been determined to be a new use of program funds. The proposed changes are substantial and require a 30-day public review and comment period. Substantial Amendment No. 2015-003 will be made available for public review and comment **December 20, 2014 through January 18, 2015.**
