However, why not draw a deeper distinction between the type of vendors you want to penalize. Also what guarantee is there that this same thinking won't eventually be extended to other areas of the community? Further limiting where vendors can operate?


If the issue is crowd control, then why not create a designated area for vending?

already happening to immigrants, do you really want to pile on more?

Also, the vendors walked away from the meeting with Karla with the understanding that this was being pressured by Food Truck operators. So why not just say that... we prefer to support food truck operators. Or better, the city want's to disincentive vendors who are not complying with all regulations. There really is no need to paint food vendors as criminals. You all know that these are just folks fighting to survive.
