eComment: I oppose this item. The issue of people congregating on Olive Avenue after the bars and clubs close has existed for decades, predating street vendors by at least 30 years. The City is attempting to make vendors a scapegoat for problems they have no part in creating. In addition, it is well known in the district that much of the problems are linked to one particular business that has been required to hire police officers as security. It would be a pleasant surprise if, instead of targeting street vendors, the City would enforce existing ordinances against this and other problematic businesses along Olive Avenue.
