WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

- 1. The Consultant shall provide additional services as described in Attachment A, which is attached hereto and incorporated herein by reference. Such additional services shall be completed within 30 calendar days following the execution of this Amendment by both parties.
- 2. The Consultant's sole compensation for satisfactory performance of all services required or rendered under this Amendment shall be a total net fee of \$38,262.
- 3. In the event of any conflict between the body of this Amendment and any exhibit or attachment hereto, the terms and conditions of the body of this Amendment shall control and take precedence. Furthermore, any terms or conditions in any exhibit or attachment that purport to modify the allocation of risk between the parties, as provided in the body of this Amendment, shall be null and void.
- 4. Except as otherwise provided herein, the Agreement remains in full force and effect.

Ashlan Avenue Widening Project between Polk Avenue and Cornelia Avenue

1. Management & Coordination:

Mark Thomas is to spend effort to review new concept necessary for the additional coordination that has been required.

2. Meetings (Up to 5):

This additional budget is for the additional meetings with the City.

3. QA/QC:

This additional budget for the Sr. Technical Engineer to review the Plan, Spec and Estimate of the project with the addition of the driveway approach improvements.

4. Construction Plans:

This adds additional budget for the work of the redesign of driveway approaches at the property APN: 51101205S along the Southside of the EB Ashlan Ave traffic. This includes the work necessary for the additional topography data request exhibit, updating the surface data with the additional topographical data, designing of Caltrans standard retaining wall with railing, design of ADA access from house to driveway, updating sheets that include the driveway improvements, updating specifications, and updating estimate.

5. Bid Documents:
