RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, AUTHORIZING AND DIRECTING
ACCEPTANCE OF STATE FUNDING TO THE CITY OF
FRESNO AND EXECUTION OF IMPLEMENTING
DOCUMENTS REGARDING THE DOWNTOWN FRESNO
INFRASTRUCTURE PLAN

WHEREAS, the City of Fresno (City) has been allocated \$250 million by the State of California (State) to revitalize Downtown Fresno by constructing additional capital projects and infrastructure improvements including water, wastewater, and sewer systems, street and sidewalk improvements, green space, transit and intermodal centers, parking structures, and other catalytic development opportunities (Downtown Fresno Infrastructure Plan); and

WHEREAS, the State has allocated \$50 million of funding through its Fiscal Year 2023-2024 budget and intends to allocate the remaining funds through multiple fiscal years; and

WHEREAS, the State's funding will ensure necessary public infrastructure supports the development of mixed-income, mixed-use housing and other development near transit and high-quality public amenities and public space; and

WHEREAS, the State's funding will significantly increase public and private investment in Downtown Fresno and local tax revenue; and

WHEREAS, in order to expedite capital projects and infrastructure improvements within the Downtown Fresno Infrastructure Plan it is necessary to timely accept State funding and execute any and all agreements with the State; and

WHEREAS, for efficiency and expediency, it is desired that City Manager, or

designee, be authorized to enter into agreements with the State to receive and use funding for the purposes for which the funds are granted to the City.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Council approves acceptance of the funds from the State of California.
2. Council hereby authorizes and directs the City Manager, or designee, to enter into agreements with the State of California to receive and use state funding for the purposes for which those funds are granted subject to approval as to form by the City Attorney.
3. The City Manager, or designee, is authorized and directed to take all actions and sign all implementing documents necessary to effectuate this resolution.
4. This Resolution shall be effective upon final approval.
