Subject: Police Department Budget and Assignments - Newly Added Positions

Honorable Mayor and Members of the City Council,

Please consider this request in connection with your action in approving the Police Department's budget for 2015-2016.

I am a long-time property owner in the Tower District. I understand that the City is considering restoring 43 new positions to the police department, and that the City may be intending to assign those positions equally among the 4 police districts.

I am asking that NONE of those restored positions be assigned to the Northeast station in the Woodward Park area. Instead, all of those positions should go to neighborhoods where police presence is most needed: in particular, to neighborhoods in Central Fresno, which suffered a serious blow when the City closed the Central District station in 2010.

Thank you for your consideration of my comments.
