A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING AND DIRECTING THE DIRECTOR OF AVIATION OR DESIGNEES TO SUBMIT APPLICATIONS FOR TRANSPORTATION SECURITY ADMINISTRATION OTHER TRANSACTION AGREEMENT FUNDING OF A CHECKED BAGGAGE FACILITY AND IN-LINE CHECKED BAGGAGE INSPECTION SYSTEM AT FRESNO YOSEMITE INTERNATIONAL AIRPORT AND TO EXECUTE ALL APPLICATION RELATED DOCUMENTS

WHEREAS, the United States of America, acting through the Department of Homeland Security, Transportation Security Administration, provides funding for the design and construction of Checked Baggage Inspection Systems to airport sponsors through an Other Transaction Agreement; and

WHEREAS, the City of Fresno is anticipating design and construction of a Checked Baggage Inspection System at Fresno Yosemite International Airport; and

WHEREAS, the City of Fresno is sponsor of Fresno Yosemite International Airport; and

WHEREAS, the City of Fresno is an eligible applicant for Transportation Security Administration Other Transaction Agreement funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

2. Council authorizes submission of applications for Transportation Security
