A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE PUBLIC WORKS DIRECTOR AND THE DEVELOPMENT AND RESOURCE MANAGEMENT DIRECTOR TO EXECUTE STANDARD AGREEMENTS WITH THE COUNTY OF FRESNO FOR DEVELOPMENT IN THE CITY'S SPHERE OF INFLUENCE, BUT NOT YET ANNEXED INTO THE CITY'S CORPORATE BOUNDARIES

WHEREAS, Title 15 of the Fresno County Ordinance Code relates to building and construction within the unincorporated territory of Fresno County; and

WHEREAS, Section 15.04.140 of Title 15 provides that when a city has commenced annexation proceeding of property upon which development is proposed, such development may be subject to the ordinances and standards of the city seeking annexation, provided such city and the County execute an agreement agreeing to the provision of Chapter 15.04; and


WHEREAS, on September 27, 2016, the County of Fresno approved an template agreement for use in relation to Section 15.04.140, which is attached hereto as Exhibit "A"; and

WHEREAS, approval of a standard agreement relating to development in the unincorporated territory of Fresno County which falls within the City of Fresno's (City) Sphere of Influence, and which City intends to annex, is an efficient use of City resources.
