

SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT (Second Amendment) made and entered into effective the 28th day of February 2019, between the CITY OF FRESNO, a California municipal corporation (City), and NBS Government Finance Group, a California corporation (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an agreement on June 29, 2018 (Agreement) to provide professional financial fee analysis consulting services for Updated Fee Study Analysis (Project); and

WHEREAS, the City and Consultant entered into an amendment, dated January 22, 2019 (Amendment);

WHEREAS, the City and the Consultant desire to extend the Agreement to March 31, 2020, to complete the Project; and

WHEREAS, with entry into this Amendment, the Consultant agrees it has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the parties agree that the aforesaid Agreement be amended as follows:

1. The recitals to this Second Amendment are incorporated and made a part of this Amendment.
2. The Agreement is extended to March 31, 2020.
3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on June 29, 2018, and amended on January 22, 2019, remains in full force and effect.
