PROJECT TITLE: Re-bid of Access Structure Rehabilitation in Jensen

Avenue from Fruit Avenue to Cherry Avenue

PROJECT LOCATIONS: Jensen Avenue between Fruit and Cherry Avenues

PROJECT DESCRIPTION: The purpose of the project is to rehabilitate existing

sewer access structures, the removal and replacement of failing coating and installation of polymer concrete inserts, including all associated facilities, appurtenances,

and incidentals.

The Project is exempt under Section 15302(c)&(d)/Class 2 of the California Environmental Quality Act (CEQA) Guidelines.

The proposed project is consistent with the Class 2 exemption. All sewer facilities involved in the Project are publicly owned utilities. The Project is necessary to correct sewer access structures structural deficiencies within the area, which involves restoration or rehabilitation of deteriorated or damaged structures, in order to meet public health standards for sewer conveyance facilities, as is consistent with a Section 15302(c) exemption.

None of the exceptions to Categorical Exemptions set forth in the CEQA Guidelines, Section 15300.2, apply:

(a) Location The Project is not located in a sensitive environment

or an environmental resource of hazardous or critical concern as designated by federal, state, or local

agencies.

(b) Cumulative Impact The Project will not have a cumulative negative

impact over time that is significant. A well is

rehabilitated once every 10 or more years and the impacts are beneficial to the operation of the well and surrounding aquifer.

(c) Significant Effect

The Project will not have a significant effect on the environment due to unusual circumstances. The well rehabilitations are routine maintenance following industry standards.

(d) Scenic Highways

The Project will not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway. The Project is not located near scenic highways.

(e) Hazardous Waste Sites The Project is not located on a hazardous waste site which is included on any list compiled pursuant to Section 65962.5 of the Government Code.

(f) Historical Resources

The Project will not cause a substantial adverse change in the significance of a historical resource. The Project is limited to rehabilitation of public water supply wells, which are not historical resources.

Furthermore, the proposed project is not expected to have a significant effect on the environment. Accordingly, a categorical exemption, as noted above, has been prepared for the project.
