### **EMPLOYMENT HISTORY**

2005-Present: After retirement, I volunteered as a Community Representative with the Fresno Department of Social Services. I attended Team Decision Meetings for families facing removal of their children for abuse or neglect. I also volunteered as a Cultural Broker in the infancy of that program. I had a case load of families that I went to court with, attended TDM, staffings, and referred clients to appropriate resources in the community. As the program progressed, I was hired as a Cultural Broker Supervisor. In this position, I supervise cultural broker staff. I read and sign off of reports, train new employees, assign cases, review on-going cases, and supervise MSW interns.

1984-2005: I started with the State of California as a Parole Agent I and retired as a Parole Agent III, Supervisor. During my course of being a parole agent; I had a caseload of felons and non-felons. I made home calls, wrote reports to the Board of Prison Term, conducted arrest, and carried a caseload of mentally ill offenders as well as sex offenders. I developed many community oriented programs to cut down the recidivism rate of parolees. I also worked at a custody facility where I was responsible for classification actions, processing inmate appeals, and getting them ready to parole.

I was an Assistant Unit Supervisor before being promoted to a supervisor. In that position I supervised ten parole agents, assigned cases, did performance evaluations, trained new staff, and developed creative community programs for employment for parolees.
