A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO ESTABLISHING FIRE STATION SERVICE
AREAS 10R, 12, 19, 24, 25 AND 26 WITHIN THE URBAN
GROWTH MANAGEMENT BOUNDARY

WHEREAS, on January 22, 1976, the City Council of the City of Fresno ("Council") adopted the Urban Growth Management ("UGM") process via Ordinance No. 76-6; and

WHEREAS, the Council has subsequently amended the UGM process to address UMG Fire Service Areas and UGM Fire Station Capital Fee allocations in the Fresno Municipal Code ("FMC"); and

WHEREAS, FMC 12-4.508(B) provides that "[t]he Council may establish by resolution Fire Station Service Areas within the Urban Growth Management Area"; and

WHEREAS, FMC 12-4.508(F)(2) provides that "[a]ll UGM Fire Station Capital Fees collected from development outside an established UGM Fire Station Service Area shall be held in a separate fund until such service area is established, at which time all such fees, together with interest thereon, shall be transferred into a UGM Fire Station Capital Fund" corresponding with the newly established area; and

WHEREAS, the Council has previously formed UGM Fire Station Service Areas within the UGM boundary, but, a significant portion of the UGM boundary remains as the Undesignated UGM Fire Station Area; and

WHEREAS, the Fire Chief of the City of Fresno has determined the appropriate service area boundaries for the remaining future fire stations within the UGM boundary.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF FRESNO HEREBY:

SECTION 1. Establishes UGM Fire Station Service Areas 10R, 12, 19, 24, 25 and 26 in accordance with the attached Exhibit "A" depicting the service area boundaries.

SECTION 2. Authorizes the Public Works Director or designee to transfer UMG Fire Station Capital Fees collected from developers and held in a separate fund (UGM Fire Station Undesignated Service Area Fund) into individual UGM Fire Station Capital Funds for UGM Fire Station Service Areas 10R, 12, 19, 24, 25 and 26 in accordance with FMC 12-4.508(F)(2).
