

**SECOND AMENDMENT TO SERVICE AGREEMENT
CITY OF FRESNO, CALIFORNIA**

THIS SECOND AMENDMENT is made this _____ day of _____, 2019, to the Service Agreement made and entered into between the CITY OF FRESNO, a California municipal corporation (CITY), and The Arc Fresno/Madera Counties, a California non-profit corporation (SERVICE PROVIDER) effective July 1, 2018 (Service Agreement).

RECITALS

WHEREAS, CITY and SERVICE PROVIDER contracted for certain trash pick-up services for Fresno Yosemite International Airport, hereinafter referred to as the "Project," on July 1, 2018;

WHEREAS, CITY and SERVICE PROVIDER entered into a First Amendment, effective July 1, 2018, which revised the Service Agreement's budget; and

WHEREAS, CITY and SERVICE PROVIDER now desire to further revise Exhibit A-1 to include additional service locations and to reflect accurate rates for SERVICE PROVIDER's services, effective June 1, 2019.

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and of the covenants, conditions, and premises hereinafter contained to be kept and performed by the respective parties, it is mutually agreed as follows:

1. Exhibit A-1 to the Service Agreement is amended and superseded as attached herein by Exhibit A-2.
2. All other terms of the Service Agreement remain in full force and effect.

Service Agreement between City of Fresno and The Arc Fresno/Madera Counties
Trash Pick-Up Services
PROJECT TITLE

Scope of Service:

Remove litter from the Fresno Yosemite International Airport (FAT).

Trash will be disposed of at an FAT Airport dumpster, however a dump fee is included to accommodate overflow.

Airport Locations:

1. Rental Car Areas;
2. Airport Locations, includes Airport Public Parking Lot; Managers Lot, Shields Avenue north to Dakota Avenue, Dakota Avenue to Aircorp Way, Aircorp Way to Leyte Avenue, Clovis Avenue to McKinley Avenue; and New Long Term Lot (formerly the old Employee Parking Lot);
3. Surface Expansion Lots, includes New Employee Parking Lot, Economy Parking Lot, and Expanded Cell Phone Waiting Area.
4. Dayton Avenue frontage road adjacent to the west side of Chestnut (SW corner of Chestnut and Dakota). The service areas will include the planter beds on west side of Dayton Avenue and the bare dirt median separating Dayton and Chestnut;
5. Trash Bags; and
6. Off Site Dumpster Fee.
