A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING THE 2015-2019 PROGRAM YEAR CONSOLIDATED PLAN AND AUTHORIZING SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR APPLICATION OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), HOME INVESTMENT PARTNERSHIPS (HOME), EMERGENCY SOLUTIONS GRANT (ESG) AND HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAMS AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD AS APPROVED TO FORM BY THE CITY ATTORNEY

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare a five-year Consolidated Plan, which identifies how the jurisdiction will address housing and community development needs with Community Development Block Grant (CDBG), Home Investment Partnerships (HOME), Emergency Solutions Grant (ESG), and the Housing Opportunities for Persons with AIDS (HOPWA) funds; and

WHEREAS, the City has undergone a comprehensive needs assessment, stakeholder consultation, and citizen participation process; and

WHEREAS, the City has reviewed census data, housing market studies, and facilitated focus groups to identify the housing and community development needs of low and moderate-income persons; and

WHEREAS, the City has met the regulatory requirements of preparing the five-year Consolidated Plan; and

SECTION 1. The Council of the City of Fresno, California, adopts the 2015-2019 Program Year Consolidated Plan and approves submission of the 2015-2019 Program Year Consolidated Plan to HUD incorporating citizen comments made during the public hearing.

SECTION 2. The City Manager is authorized to sign all certifications, applications, instruments, funding agreements, and the like necessary in pursuit hereof, subject to prior approval as to form by the City Attorney.

SECTION 3. This Resolution shall become effective upon its adoption.
