WHEREAS, the City of Fresno (City) is an annual recipient of United States Department of Housing and Urban Development (HUD), Community Development Block Grant Program, and HOME Investment Partnerships funds; and

WHEREAS, a condition for use of these HUD Program funds requires the City to certify it will annually comply with the requirements of Section 3 pursuant to 24 CFR 570.607(b); and

WHEREAS, the United States Congress passed Section 3 of the HUD Act of 1968 (Section 3) to further the goal of ensuring residents of the City received employment opportunities on projects in whole, or in part, with HUD Program funds, and

WHEREAS, Part 135 of Section 3 is to establish the practices and procedures to be followed to ensure the objectives of Section 3 are met;

WHEREAS, City staff has developed a Section 3 Plan for the City to use on CDBG and HOME Program activities in adherence with 24 CFR, Part 135 that will ensure compliance with the standards and procedures prescribed in the Act; and

WHEREAS, the City's Section 3 Plan has been reviewed by the City's Certifying Officer with comments incorporated into the Plan; and

WHEREAS, the City has adopted this Resolution approving City's Section 3 Plan for use on City HUD-funded projects.
