A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ESTABLISHING RATES OF FARE TO BE CHARGED BY TAXI CABS IN THE CITY OF FRESNO.

WHEREAS, Fresno Municipal code Section 9-915 authorizes the Council to establish rates for mileage, drop charges, and waiting time applicable to all taxi cabs which rate shall increase due to changes in Consumer Price Index; and

WHEREAS, the Council of the City of Fresno finds that the establishment of such rates as set forth in this resolution is in the interest of the public.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. RATES OF FARE

Rates of fare to be charged to the public for the use of taxi cabs shall be amended as follows, which rates shall increase due to changes in the Consumer Price Index:

A. For taxi cabs operating on a mileage basis, the drop charge for the first mile shall not be less than \$3.00 or more than \$10.00. The rate for each additional mile shall range from \$2.45 to \$3.00. Permittees shall inform consumers of the rate then in effect at the time the service is contracted and prior to initiating the trip.

B. Nothing herein shall prevent a permittee from offering discounts to any person or group, nor from contracting with firms or organizations for services at rates less than those provided herein, to the extent allowed by controlling law.
