A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DECLARING APNS 510-326-32T AND 510-326-33T TO BE SURPLUS AND DIRECTING STAFF TO COMPLY WITH THE SURPLUS LAND ACT

WHEREAS, the City of Fresno is the owner of real properties located at 4170 North Brix Avenue (APN 510-326-32T) and 4176 North Brix Avenue (APN 510-326-33T), (Properties). The Properties are more particularly described in the Legal Descriptions attached as Exhibits "A-1" and "A-2" to this Resolution. In addition, the parcel map is attached as "Exhibit B," and

WHEREAS, under the Surplus Land Act, Government Code Sections 54220, *et seq.*, surplus land means land owned in fee simple for which a local agency's governing body takes formal action at a regular public meeting declaring land to be surplus and not necessary for a local agency's use; and

WHEREAS, land must be declared either "surplus" or "exempt surplus" as supported by written findings before a local agency may take any action to dispose of it consistent with an agency's policies or procedures; and

WHEREAS, except as otherwise provided in the Surplus Land Act and Guidelines, "agency's use" shall include, but not be limited to, land that is being used, or is planned to be used pursuant to a written plan adopted by the local agency's governing board for agency work or operations, including, but not limited to, utility sites, watershed property, land being used for conservation purposes, land for demonstration, exhibition, or educational purposes related to greenhouse gas emissions, and buffer sites near sensitive governmental uses, including, but not limited to, waste water treatment plants

as described in Government Code Section 54221(c)(1). Agency's use shall not include commercial or industrial uses or activities, including nongovernmental retail, entertainment, or office development. Property disposed of for the sole purpose of investment or generation of revenue shall not be considered necessary for the agency's use; and

WHEREAS, staff has identified the Properties as potential surplus real property and wishes to dispose of the Properties; and

WHEREAS, pursuant to Government Code Section 54222, City staff will send a written Notice of Availability to sell the surplus Properties to the entities and agencies identified in Government Code Sections 54222, et seq., and if one of the entities/agencies desires to purchase the Properties after having received notice, it must indicate its intent to do so in writing within 60 days of receiving the notice, and the City and the other entity/agency shall negotiate in good faith for a period of 90 days on the price and terms for the disposition of the Properties; and

WHEREAS, pursuant to Government Code Section 54230. 5, City staff will provide to the Department of Housing and Community Development a description of the notices of availability sent, and negotiations conducted with any responding entities, in regard to the disposal of each parcel of surplus land; and

WHEREAS, in the event no agreement is reached between the City and any interested entity/agency to whom notice is provided, staff will present Council with proposals for disposition of the surplus Properties.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

- 1. The City Council hereby declares the Properties located at 4170 North Brix Avenue (APN 510-326-32T) and 4176 North Brix Avenue (APN 510-326-33T) Fresno, California 93722, to be surplus; and the City therefore intends to dispose of said Properties.
- 2. City staff is hereby directed to send all notices and take all actions required by the Surplus Land Act so that it may dispose of the Properties.
 - 3. This resolution shall be effective upon final approval.


