

FIRST AMENDMENT TO AGREEMENT

For development of specialized user products
(reports and scripting) related to Accela implementation

THIS FIRST AMENDMENT TO AGREEMENT (Amendment) made and entered into as of this 1st day of December, 2017, amends the Agreement entered into between the CITY OF FRESNO, a municipal corporation (City), and SILVER LINING SOLUTIONS, LLC (Consultant). The City and the Consultant are collectively referred to as the "Parties" in this Amendment.

RECITALS

WHEREAS, City and Consultant entered into an Agreement dated June 26, 2017, for professional IT and Civic Platform services for ongoing Accela Civic Platform development and maintenance, and

WHEREAS, City desires to amend the original scope of work to include an additional 356 hours dedicated to developing easy and moderate level reports and scripting for Batch, ACA, or AA.

AMENDMENT

NOW, THEREFORE, the Parties agree that the Agreement is amended as follows:

1. Consultant shall provide additional services related to the development of easy and moderate level reports and scripting for Batch, ACA, or AA described in the original contract dated June 26, 2017.
2. Consultant's compensation for performance of all services required or rendered pursuant to this Change Order Amendment shall be a total fee not to exceed Fifty Thousand and 00/100 Dollars (\$50,000.00).
3. This Amendment shall become part of and subject to the terms and conditions of the Agreement, which except as modified herein, remains unchanged and in full force and effect. However, to the extent that the terms and conditions expressly set forth in this Amendment conflict with the terms and conditions of the Agreement, the terms and conditions expressly set forth in this Amendment will prevail. Unless otherwise defined in this Amendment, capitalized terms used herein shall have the meanings assigned to such terms in the Agreement.
