

SECOND AMENDMENT TO AGREEMENT

THIS SECOND AMENDMENT TO AGREEMENT (Amendment) made and entered into effect the 17TH day of April, 2024, (Effective Date) amends the Agreement heretofore entered into between the CITY OF FRESNO, a California municipal corporation (City), and CAROLLO ENGINEERS, Inc., a Delaware corporation (Consultant).

RECITALS

WHEREAS, the City and the Consultant entered into an agreement on May 31, 2023, (Agreement) to provide professional engineering services for the Downtown Water & Wastewater Infrastructure Improvement Study (Project); and

WHEREAS, on November 27, 2023 the first Amendment to the Agreement (First Amendment) was executed to expand the Consultant's scope of services to include design, bidding support, and construction support services related to the Project and increasing the Consultant's total to \$2,737,279, and an amended contingency amount not to exceed \$374,000; and

WHEREAS, the City and the Consultant desire to use the new labor rate for 2024 outlined in the Carollo 2024 Fee Schedule; and

WHEREAS, with entry into this Agreement, the Consultant agrees the Consultant has no claim, demand, or dispute against the City.

AGREEMENT

NOW, THEREFORE, the Parties agree that the aforesaid Agreement be amended as follows:

1. **Exhibit A** of the Agreement is amended to update the schedule of fees as indicated in **Exhibit A2** attached hereto and incorporated herein by reference.

2. The Consultant's sole compensation for satisfactory performance of all services required or rendered pursuant to this Agreement shall not exceed \$2,737,279 including a contingency of \$374,000 paid on a time and material basis in accordance with the schedule of fees contained in **Exhibit A2**. Such fee includes all expenses incurred by the Consultant in performance of said services.

3. Except as otherwise provided herein, the Agreement entered into by the City and the Consultant on May 31, 2023 and the First Amendment entered into on November 27, 2023, remains in full force and effect.
