A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING SUBSTANTIAL AMENDMENT NO. 2015-006 TO THE FY 2015-2016 ANNUAL ACTION PLAN; APPROVING SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR REPROGRAMMING \$3.5 MILLION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FUNDS; PROVIDING FOR SUBRECIPIENT AGREEMENTS; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD APPROVED AS TO FORM BY THE CITY ATTORNEY.

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires all jurisdictions that receive federal entitlement funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG) Program funds; and

WHEREAS, on June 23, 2015 the Council of the City of Fresno adopted Resolution 2015-110 approving the City of Fresno 2015-2016 Annual Action Plan; and

WHEREAS, the City has identified an additional \$3.5 million for reprogramming; and

WHEREAS, the City has prepared Substantial Amendment 2015-006 to the FY 2015-2016 Annual Action Plan, consistent with the five year Consolidated Plan, which the City Council adopted on June 23, 2015; and

WHEREAS, the thirty-day public review and comment period concluded on May 9, 2016; and

WHEREAS, the City desires to submit Substantial Amendment 2015-006 to the FY 2015-2016 Annual Action Plan to HUD to reflect changes made by the City Council.
