A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, DECLARING ELECTION RESULTS

ANNEXATION NO. 137

WHEREAS, on June 22, 2017, the Council of the City of Fresno ("Council") adopted Resolution No. 2017 - _____ calling a special mailed-ballot election on levying special taxes on land within, and on approving an annual appropriations limit for Annexation No. 137 to Community Facilities District No. 2 ("CFD No. 2"); and

WHEREAS, the Council has received, reviewed and hereby accepts the City of Fresno City Clerk's ("City Clerk") Canvass and Statement of Election Results, dated _____, 2017, a copy of which is attached as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council finds and declares that: (a) the ballot measure on the levy of taxes and approval of an annual appropriations limit for Annexation No. 137, has been submitted to the qualified electors within the area of Annexation No. 137, pursuant to Resolution No. 2017 - _____, and (b) the ballot measure has been passed and approved by more than two-thirds of the votes cast, in accordance with City of Fresno Special Tax Financing Law, Chapter 8, Division 1, Article 3, of the Fresno municipal Code ("City Law").

The Council declares Annexation No. 137 to be fully formed and the property within Annexation No. 137, to be subject to the levy of the special taxes and the special tax lien described in Resolution No. 2017 -_____, annexing Final Tract Map No. 5513 as Annexation No. 137, and authorizing the levy of a special tax therein, and Council Resolution No. 97-126, approving local goals and policies for Community Facilities Districts, as described in the Community Facilities District Report dated as of May 26, 2017, on file with the City Clerk.

3. The Council directs the City Clerk or designee to record a notice of special tax lien in the Office of the County Recorder, pursuant to City Law, no later than 15 days after this resolution is adopted.
