A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION OF UP TO \$500,000 FROM THE STATE OF CALIFORNIA OFFICE OF TRAFFIC SAFETY TO FUND THE PROCUREMENT OF TRAFFIC DATA ANALYSIS SOFTWARE AND AUTHORIZING PUBLIC WORKS DIRECTOR OR DESIGNEE TO ACCEPT AND EXECUTE ALL APPLICATION AND GRANT AGREEMENT DOCUMENTS ON BEHALF OF THE CITY OF FRESNO

WHEREAS, the State of California Office of Traffic Safety (OTS) announced the call for projects and applications for Federal Fiscal Year 2027; and

WHEREAS, the City of Fresno (City) Public Works Department is seeking authority for the Public Works Director or Designee to apply for and accept funding for the acquisition of traffic collision analysis software that will manage and analyze collision and traffic safety data, aid staff in the identification of traffic safety patterns and trends, and support data-driven decision-making; and

WHEREAS, the City, if successful, will enter into a grant agreement with OTS for the implementation of the grant-funded project; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council authorizes the Public Works Director or designee to apply for a grant of up to \$500,000 from the OTS Federal Fiscal Year 2027 grant program to acquire a traffic collision analysis software.
2. Council authorizes the Public Works Director or designee to accept funding, conduct negotiations, execute, submit, and sign all documents including but not limited to
