A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, DECLARING AN URGENT NECESSITY FOR THE PRESERVATION OF LIFE, HEALTH, PROPERTY, AND AUTHORIZING THE PURCHASING MANAGER OF THE FINANCE DEPARTMENT OR DESIGNEE TO CONTRACT FOR THE REPLACEMENT OF THE CITY HALL ELECTRICAL SYSTEM BUS DUCT AND ASSOCIATED REPAIRS WITHOUT ADVERTISED COMPETITIVE BIDDING TO A-C ELECTRIC COMPANY

WHEREAS, the City of Fresno (City) owns and operates the property at 2600 Fresno Street known as City Hall; and

WHEREAS, City Hall is powered by electricity from PG&E; and

WHEREAS, the electricity runs through a bus duct to the electrical panel; and

WHEREAS, on December 1, 2019 the bus duct failed and burned resulting in loss of electricity to City Hall; and

WHEREAS, a temporary generator is being used to power City Hall; and

WHEREAS, the bus duct needs to be replaced and is a custom item; and

WHEREAS, it has been determined that A-C Electric Company can most cost effectively provide the services and materials necessary to perform this repair, due to the fact that they have a sub-contractor who will rebuild the bus duct in a relatively short amount of time; and

WHEREAS, further delays could have a serious financial impact due to the cost of the temporary generator being \$9,000 per day, \$23,600 per week or \$61,280 per month; and

WHEREAS, replacement of the bus duct will take an estimated three weeks, and

the delays inherent in advertising for bids will unacceptably delay commencement of the repair several additional weeks; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The foregoing facts constitute an urgent necessity for the preservation of life, health, or property.

2. The requirement of advertising for bids is hereby waived pursuant to Charter Section 1208(a)

3. The Purchasing Manager of the Finance Department or designee is authorized to enter into and execute contracts, documents and instruments providing for the replacement of the bus duct at City Hall and associated repairs, at a cost not to exceed \$400,000, and subject to prior approval as to form by the City Attorney's Office.
