WHEREAS, it is understood by the City of Fresno that failure for not meeting

project delivery dates for any phase of a project may jeopardize federal or state funding

to the Fresno Region; and

WHEREAS, the City of Fresno demonstrates dedicated and available local

matching funds;

SECTION 3. Appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all grant application related documents, subject to prior approval as to form by the City Attorney's Office.
