Hi Thank you for your time:

I have been communicating with some of the unhoused community regarding detailed suggestions and priorities and have some of my own.

I want to suggest that the housing department consider the recommendations from the Hear To Stay Report, which is the community's priorities for all of these topics. They did extensive information gathering and had themed workshops to go over different areas of anti-displacement improvements, which addresses topics that participants didn't really get to in the workshops.

I've been watching information regarding opportunities for community input and honestly, there isn't very much engaging outreach to get people involved. I think it is excellent that the HCCD has kept the information of previous attendees, as this has allowed me to share the events to those I know are invested and communicate on social media.

Better communication and engagement should be a top priority. My suggestions:

•

- All information should be accessible, as far as understandable and to the point, for those who aren't already versed in civic
- engagement, in all languages.

•

- A social media expert should be involved, who would have the understanding to create image based postings and have knowledge
- of how to increase engagement.

•

- Regarding social media the city only puts out one post (like for these workshops) and often doesn't post at all. If community
- input is requested and especially required, there should be a campaign to ensure maximum reach.

- At the Here To Stay workshops, people suggested that the city utilize forms of communication such as a voluntary text message
- notification and putting information in utility letters (though renters may not get these). I would suggest have an opportunity to subscribe to notification emails. There should also be non-internet based communication, like paper surveys available that organizations
- can use.

•

Regarding the homeless, most opportunities to engage are inaccessible. Those who are unhoused do not know about meetings, most do not have data to access meetings and do now know how to engage. Those who are unhoused are major stakeholders and investment should be made into overcoming accessibility issues. They understand their needs best and can provide the information that will help the city better address homeless response. The lack of involvement leads to oversight in executing a successful project. For instance, the cooling centers previously did not allow pets. The unhoused with pets refused to go and eventually an advocate brought it up to city council and this was changed. This detail is the kind of feedback the unhoused can give to projects to ensure the project is truly accessible to the unhoused. This was also an issue when the only shelters didn't allow pets ot couples and people not wanting to be separated from either would be declined and, not understanding this caveat, people assumed that they don't want to follow rules. The unhoused can also best address incorrect information, such as I referenced.

As such, I want to suggest:

•

- Development of ongoing meetings, like homeless advisory that includes members that are unhoused and have lived experience
- that would allow the unhoused to have a say in decision making for projects, but reach out to the unhoused on how this could best be realized. For instance, they may not want to have police or other types of authority at a meeting if that may affect their
- sense of safety in sharing ideas. One of the council members as hosting a town hall at the shelters, so this is one way. Or at different locations in the city, like eaton Plaza, the libraries, city hall.

•

- Have discussion on all areas such as: how to improve outreach. Where the next shelters/ housing should be. What are their
- current needs and challenges to accessing services and what they need to move forward. Essentially
 like what is being asked of during this. They should have an opportunity to give feedback before and
 during projects, and note what it will take to be effective.

•

Other suggestions to improve access and communications:

Invest in Wi-Fi at all the shelters.

One advocate suggested tablets so they can participate in community meetings, fill out surveys, etc.,
 and engage in other

ways.

•

- Training on how to use platforms like Zoom. I once had to sit with a woman who had a lot of ideas and wanted to attend meetings
- and workshops for various things, but couldn't figure out how to use Zoom on her own or download it on her computer.

.

Invest in Bulletin boards that are installed at all the bus stations to post communications.

•

- During outreach, have paper surveys for general topics like needs priorities, like the questions asked at the workshops and
- specific surveys on ways to improve specific programs/ projects. One county took these out during the PIT count. Partner with other organizations assisting the unhoused to provide and assist in these surveys.

•

Homeless Services

•

- The unhoused are asking that shelters and other such services and development be in all districts. There are reasons for this:
- they feel safer in the neighborhoods in which they dwell, they have jobs in those areas, and there are
 other resources they access that make up their community area.

•

- Again, wi-fi in all shelters as well as computer rooms, access to tablets and such. This is needed for accessing jobs, doing
- online meetings with counselors and such. As mentioned above, help with computer/online literacy is needed.

•

- At the shelters and libraries, etc., bring in resources: Host trainings on needed life skills, bring in agencies and companies
- that hire those who are homeless and can train them. Etc.

•

- Day centers and MAPS in all districts in the community. Those who are unhoused have difficulty having to get to various services
- and there are many who are disabled and have limited mobility. Perhaps work with existing facilities. These services should be located by buses.
- City homeless services like warming centers and cooling centers in every district, multiples if possible.
- Mobile medical and dental.
- I am very grateful for Councilmember Arias' effort to get a medical center by the shelters on Parkway. This needs to be a
- priority. Also, include mental health services within this facility.
- Investment in 24 hour mental health professional services in each shelter.
