The Fresno Yosemite International Airport (FAT) Commercial West Ramp Reconstruction project is funded through the Federal Aviation Administration Airport Improvement Program and Measure C transportation tax. The project replaces the existing pavement west of the airport terminal and includes storm drain improvements, potable water services, lighting, electrical infrastructure, vehicle charging stations, and security fence enhancements.






