A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, AUTHORIZING THE DIRECTOR OF AVIATION OR OTHER AUTHORIZED REPRESENTATIVE TO EXECUTE ALL IMPLICATED DOCUMENTATION FOR APPLICATION TO THE SAN JOAQUIN VALLEY AIR POLLUTION CONTROL DISTRICT FOR GRANTS BENEFITING FRESNO YOSEMITE INTERNATIONAL AIRPORT AND FRESNO CHANDLER EXECUTIVE AIRPORT, AND EXECUTE ALL DOCUMENTS REQUIRED TO ACCEPT ANY GRANTS RESULTING FROM SAID APPLICATIONS FOR BOTH AIRPORTS, INCLUDING ANY SUBSEQUENT AMENDMENTS THERETO

WHEREAS, the San Joaquin Valley Air Pollution Control District (SJVAPCD) administers grant programs to provide funds for projects improving air quality; and

WHEREAS, the SJVAPCD is requesting applications from eligible entities for proposed grant awards; and

WHEREAS, the SJVAPCD procedures require applicants certify by resolution evidence of the applicant's governing body's approval to submit applications to the SJVAPCD and execute grant documents with SJVAPCD; and

WHEREAS, the Airports Department desires to submit applications to the SJVAPCD for grant funding on an ongoing basis.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Fresno, State of California, that:

1. Submittal of applications for SJVAPCD grants by the Director of Aviation or designee is hereby approved.
2. Grant offers from the SJVAPCD, including amendments thereto, are hereby approved and accepted when received, consistent with Constitutional and local law
