# Greetings,

HBC submitted a bid to the city on November 5th, 2024 for the construction of 8 Pickleball Courts at Rotary East Park. HBC was the apparently low bidder and has subsequently been awarded the contract to construct the park improvements.

HBC requests the ability to substitute a subcontractor based on the following material factors.

HBC received a quote to perform specialty coating work scopes from Tosted Asphalt in the amount of \$34,500.00. The quote was not broken out per the bid schedule and I requested by email and phone for this to happen so I could plug their costs into the bid compilation sheet as accurately as possible.

I called their office a few times asking to speak to someone and was told the person who completed and submitted the bid (Junior) was in the mountains working and did not have phone signal. I then asked for someone else to call me to review the numbers and was met with negative results because the manager was busy in a meeting. Knowing the difference between Tosted's bid and the next lowest quote HBC received was minimal, I listed Toasted to perform the work on the project according to the bid schedule completed and submitted to the city electronically.

After I provided my Office Manager the final bid numbers to submit via the Planet Bids platform, I went back to my daily routine of checking emails etc.... During this transition, at 2:58pm, I found an email from Tosted. This email was sent at 12:10pm, and it contained a 'revised' estimate that was over double what their initial quote sent to HBC. The new quote was for the amount of \$85,000.00. Attached you will see my correspondence to Tosted concerning the revised bid receipt stating it was not received/nor reviewed until AFTER our bid was submitted to the city.

I tried talking with Tosted on the phone and received the attached email correspondence from them regarding their original quote. Please see their explanation via the attached emails.

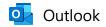
Also, please see the quote supplied by Beynon. Their quote for the same work was <u>\$37,615.00</u>. There is no vast difference between the quotes, so there was zero indication to HBC there could actually be something of

significance that was missed or misquoted by Tosted. HBC acted in a prudent manner by listing the apparent low bidder for the specified work scopes, and Tosted has refused to perform according to their original bid.

Due to Tosted's actions that were outside of HBC's control, we 'respectfully' request the ability to substitute BEYNON to perform the work scopes that were originally at the time of bid to be performed by Tosted Asphalt.
