THE PROJECT DESCRIBED HEREIN IS DETERMINED TO BE STATUTORILY EXEMPT FROM THE PREPARATION OF ENVIRONMENTAL DOCUMENTS PURSUANT TO ARTICLE 18 OF THE STATE CEQA GUIDELINES AND SECTION 21080.13 OF THE CALIFORNIA PUBLIC RESOURCES CODE.

PROJECT DESCRIPTION: The project will eliminate 2 existing at grade crossings by grade

separating N. Blackstone Avenue and E. McKinley Avenue under the BNSF Mainline Track. The project will require Right of Way acquisitions, utility relocations, will be compatible and complementary to the "Better Blackstone" Initiative and the South Blackstone Smart Mobility Strategy. The project will improve on-time service performance for the City's Bus Rapid Transit Service and remedy traffic for Fresno City College located at the northwest quadrant of

the Blackstone and McKinley intersection.

This project is statutorily exempt under Sections 21080.13(a) of the California Public Resources Code, and 15282(g) of the California Environmental Quality Act (CEQA) Guidelines.

EXPLANATION:

Chapter 26 of the Public Resources Code articulates when the division of the PRC requiring assessment pursuant to the CEQA Guidelines shall apply to discretionary projects. In so doing, it sets forth a number of statutory and categorical exemptions for certain projects that by their nature are not required to be subject to the division. Public Resources Code Section 21080.13 specifically identifies a statutory exemption for railroad grade separation projects and states as follows:

(a) This division shall not apply to any railroad grade separation project that eliminates an existing grade crossing or that reconstructs an existing grade separation.

(b) (2) Whenever a local agency determines that a project is not subject to this division pursuant to this section, and it approves or determines to carry out the project, the local agency shall file a notice with the Office of Planning and Research and with the county clerk in each county in which the project will be located in the manner specified in subdivisions (b) and (c) of Section 21152.

In addition, CEQA Guidelines Section 15282 sets forth a list of various statutory exemptions and specifically identifies certain railroad grade separation projects as statutorily exempt as follows:

(g) Any railroad grade separation project which eliminates an existing grade crossing or which reconstructs an existing grade separation as set forth in Section 21080.13 of the Public Resources Code.

This approval clearly meets the requirements of Public Resources Code Section 21080.13 and CEQA Guidelines Section 15282 because it will eliminate two existing at grade crossings with the construction of the Blackstone/McKinley Grade Separation. As such, this project is statutorily exempt from the requirements of CEQA.
