A RESOLUTION OF THE COUNCIL OF THE CITY OF CALIFORNIA, IN ITS CAPACITY FRESNO. SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF FRESNO, DEDICATING THAT PORTION OF SUCCESSOR AGENCY OWNED PROPERTY FOR PUBLIC STREET PURPOSES FOR SANTA CLARA STREET, BETWEEN O STREET AND N STREET

WHEREAS, the City of Fresno conveyed the real property located on Santa Clara Street between O Street and N Street to the Fresno Redevelopment Agency by Quitclaim Deed recorded on February 13, 2004, as Document No. 2004-0034758.; and

WHEREAS, the Successor Agency to the Redevelopment Agency (Agency) of the City of Fresno would like to dedicate Santa Clara Street, between O Street and N Street to the City for public street purposes; and

WHEREAS, the proposed areas to be dedicated are described in Exhibit A and shown on Exhibit B, which exhibits are incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno in its capacity as Successor Agency as follows:

- That those portions of Agency-owned property described in Exhibit A and 1. shown on Exhibit B" are hereby dedicated for the purpose of a public street easement.
- Nothing contained in this resolution shall be deemed or interpreted by any 2. party to cause any interest created in the public pursuant to this resolution to ripen into any title, interest, or right of the public against or adverse to the rights of the City of Fresno nor shall this resolution limit, restrict, or modify the exemption of public property to title by prescription as defined within California Civil Code Section 1007.

The original resolution shall be returned to the City Clerk after recordation and a certified copy thereof shall be filed in the Public Works deed file.
