## **1. PROBLEM STATEMENT**

The loss of life, injuries and property damage resulting from preventable traffic crashes is a problem that greatly impacts our community and the quality of life in the City of Fresno. Our long time partnership with the California Office of Traffic Safety (OTS) has certainly helped us develop and implement strategies that have resulted in countless lives being saved. The Fresno Police Department is committed to traffic safety and the elimination of intoxicated and impaired drivers on our roadways. In addition to impaired drivers, our city struggles with pedestrian- and bicyclist-involved traffic injuries and fatalities.

The prosecution of offenders driving under the influence (DUI) and repeat offenders also poses a significant challenge, and drivers committing moving traffic violations that could result in a crash are always a concern. The following narrative will expand on these issues and address why we seek OTS funding.

The City of Fresno is the fifth largest city in California, with the Fresno Metropolitan Area having a population estimated at 1.1 million. The city has an increased poverty level, low education rate and covers over 114 square miles. These factors all contribute to increased numbers of individuals impacted by traffic-related crimes.

In 2019, 44 individuals lost their lives in traffic fatalities within the City of Fresno jurisdiction. A staggering 27 of the parties involved were under the influence of alcohol, illicit drugs or prescribed medication at the time of the crash. This includes those at fault as well as the victims, with the toxicology results of at least 3 parties still pending. An at fault motorist who was DUI of alcohol, drugs, or a combination of both, was the proximate cause in 14 of the fatal crashes. All of these crashes were preventable, and the Department is dedicated to obtaining the goal of zero DUI fatalities.

The prosecution of individuals for DUI injury and fatal crashes is becoming increasingly challenging, requiring lengthy and time consuming investigations, the use of technologically advanced methods, highly trained officers and detectives, and an increased level of inter-agency cooperation. The number of repeat DUI offenders who fail to appear in court continues to rise, requiring staffing and monitoring to ensure they do not re-offend. We plan to conduct warrant service operations to ensure the respective offenders are held accountable for their DUI crimes. Currently, the Fresno Police Department is working with the the Fresno County District Attorney's Office and the Fresno County Probation Office to monitor and arrest DUI warrant or probation violators. With the help of prior OTS grant awards, we are the only agency in Fresno County to have taken on this initiative .

Last year, pedestrian- and bicyclist-involved fatal traffic crashes accounted for 53 percent of the city's overall traffic-related fatalities. This was a decrease of 8 pedestrian and bicyclist fatalities in comparison to 2018. However, there were still 14 bicyclists and 3 pedestrians killed on our streets in 2019.

Traffic violations will continue to rise with an ever-increasing population. With the assistance of OTS funding, emphasis on existing programs and new strategies, combined with multi-faceted approaches designed to address each of these issues, will be implemented by the Department in order to reach the greatest population while focusing on the root causes of these crashes.

10. Reduce the number of persons injured in drug-involved crashes.

11. Reduce the number of persons killed in alcohol/drug combo-involved crashes.
12. Reduce the number of persons injured in alcohol/drug combo-involved crashes.
13. Reduce the number of motorcyclists killed in traffic crashes.
14. Reduce the number of motorcyclists injured in traffic crashes.
15. Reduce hit & run fatal crashes.
16. Reduce hit & run injury crashes.
17. Reduce nighttime (2100 - 0259 hours) fatal crashes.
18. Reduce nighttime (2100 - 0259 hours) injury crashes.

4. Send law enforcement personnel to the NHTSA Advanced Roadside Impaired Driving Enforcement (ARIDE) 16 hour POST-certified training.	2

Signs for DUI/DL checkpoints should read "DUI/Driver's License Checkpoint Ahead." OTS does not fund or support independent DL checkpoints. Only on an exception basis and with OTS pre-approval will OTS fund checkpoints that begin prior to 1800 hours. When possible, DUI/DL Checkpoint screeners should be DRE- or ARIDE-trained.	12

### 3. METHOD OF PROCEDURE

#### A. Phase 1 – Program Preparation (1<sup>st</sup> Quarter of Grant Year)

- The department will develop operational plans to implement the “best practice” strategies outlined in the objectives section.
- All training needed to implement the program should be conducted this quarter.
- All grant related purchases needed to implement the program should be made this quarter.
- In order to develop/maintain the “Hot Sheets,” research will be conducted to identify the “worst of the worst” repeat DUI offenders with a suspended or revoked license as a result of DUI convictions. The Hot Sheets may include the driver’s name, last known address, DOB, description, current license status, and the number of times suspended or revoked for DUI. Hot Sheets should be updated and distributed to traffic and patrol officers at least monthly.
- Implementation of the STEP grant activities will be accomplished by deploying personnel at high crash locations.

#### Media Requirements

- Issue a press release announcing the kick-off of the grant by November 15, but no earlier than October 1. If unable to meet the November 15 date, communicate reasons to your OTS Coordinator. The kick-off press releases and any related media advisories, alerts, and materials must be emailed for approval to the OTS Public Information Officer at [pio@ots.ca.gov](mailto:pio@ots.ca.gov), and copied to your OTS Coordinator, 14 days prior to the issuance date of the release.

#### B. Phase 2 – Program Operations (Throughout Grant Year)

- The department will work to create media opportunities throughout the grant period to call attention to the innovative program strategies and outcomes.

#### Media Requirements

- Send all grant-related activity press releases, media advisories, alerts and general public materials to the OTS Public Information Officer (PIO) at [pio@ots.ca.gov](mailto:pio@ots.ca.gov), with a copy to your OTS Coordinator. The following requirements are for grant-related activities and are different from those regarding any grant kick-off release or announcement.
- If an OTS-supplied, template-based press release is used, there is no need for pre-approval, however, the OTS PIO and Coordinator should be copied when at the same time as the release is distributed to the press.
- If an OTS-supplied template is not used, or is substantially changed, a draft press release shall be sent to the OTS PIO for approval. Optimum lead-time would be 10 days prior to the release distribution date, but should be no less than 5 working days prior to the release distribution date.
- Press releases reporting the immediate and time-valued results of grant activities such as enforcement operations are exempt from the recommended advance approval process, but still should be copied to the OTS PIO and Coordinator when the release is distributed to the press.
- Activities such as warrant or probation sweeps and court stings that could be compromised by advanced publicity are exempt from pre-publicity, but are encouraged to offer embargoed media coverage and to report the results.
- Use the following standard language in all press, media, and printed materials: Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.
- Email the OTS PIO at [pio@ots.ca.gov](mailto:pio@ots.ca.gov) and copy your OTS Coordinator at least 30 days in advance, a short description of any significant grant-related traffic safety event or program so OTS has sufficient notice to arrange for attendance and/or participation in the event.
- Submit a draft or rough-cut of all printed or recorded material (brochures, posters, scripts, artwork, trailer graphics, etc.) to the OTS PIO at [pio@ots.ca.gov](mailto:pio@ots.ca.gov) and copy your OTS Coordinator for approval 14 days prior to the production or duplication.
- Space permitting, include the OTS logo, on grant-funded print materials; consult your OTS Coordinator for specifics and format-appropriate logos.
- Contact the OTS PIO or your OTS Coordinator, sufficiently far enough in advance of need, for consultation when deviation from any of the above requirements might be contemplated

#### C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

1. Prepare and submit invoice claims (due January 30, April 30, July 30, and October 30)
2. Prepare and submit Quarterly Performance Reports (QPR) (due January 30, April 30, July 30, and October 30)

- Collect and report quarterly, appropriate data that supports the progress of goals and objectives.
- Provide a brief list of activity conducted, procurement of grant-funded items, and significant media activities. Include status of grant-funded personnel, status of contracts, challenges, or special accomplishments.
- Provide a brief summary of quarterly accomplishments and explanations for objectives not completed or plans for upcoming activities.
- Collect, analyze and report statistical data relating to the grant goals and objectives.

#### **4. METHOD OF EVALUATION**

Using the data compiled during the grant, the Grant Director will complete the "Final Evaluation" section in the fourth/final Quarterly Performance Report (QPR). The Final Evaluation should provide a brief summary of the grant's accomplishments, challenges and significant activities. This narrative should also include whether goals and objectives were met, exceeded, or an explanation of why objectives were not completed.

#### **5. ADMINISTRATIVE SUPPORT**

This program has full administrative support, and every effort will be made to continue the grant activities after grant conclusion.
