A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, REQUESTING CONSENT OF THE
CITY OF CLOVIS TO RENEW THE FRESNO/CLOVIS
TOURISM BUSINESS IMPROVEMENT DISTRICT

WHEREAS, the Council of the City of Fresno (City) desires to begin proceedings to renew the Fresno/Clovis Tourism Business Improvement District (FCTBID); and

WHEREAS, lodging business and short-term rental owners have requested that the Council renew the FCTBID; and

WHEREAS, a portion of the territory proposed to be included in the FCTBID lies within the boundaries of the City of Clovis, as shown on the map attached hereto as Exhibit A and incorporated herein by such attachment; and

WHEREAS, the area of the City of Clovis which lies within the boundaries of the proposed FCTBID will, in the opinion of the Council, be benefited by the improvements and activities, and the purpose sought to be accomplished by the work can best be accomplished by a single comprehensive scheme of work.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The above recitals are true and correct.
2. Consent of the City of Clovis, through its respective City Council, is hereby requested to renew the FCTBID, and to grant to the Council jurisdiction for all the purposes in connection with creation, operation, and future renewals of the proposed FCTBID.

3. The Clerk of the Council is hereby directed to transmit a certified copy of this Resolution to the City Clerk of the City of Clovis.

4. This resolution shall be effective upon final approval.
