RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE FRESNO COUNCIL OF GOVERNMENTS FOR THE 2025 MEASURE "C" TRANSIT ORIENTED DEVELOPMENT PROGRAM, CYCLE XIII, IN AN AMOUNT UP TO \$1,520,000 FOR PROJECT(S) TO SUPPORT TRANSIT ORIENTED DEVELOPMENT, AND AUTHORIZING THE EXECUTION OF GRANT AGREEMENT AND APPLICATION RELATED DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the City of Fresno is an eligible applicant of the Measure C Transit Oriented Development (Measure C TOD) Program, Cycle XIII; and

WHEREAS, eligible entities can use Measure C TOD funds for the purpose of supporting community-based transit projects through inclusive planning process with broad private-public based partnerships and outreach, improve the range of transportation choices by supporting transit facilities and improving links between facilities and activity nodes, or by supporting well-designed, high-density housing and mixed uses near transit; and

WHEREAS, the Fresno Council of Governments administers the program and has requested applications from eligible agencies; and

WHEREAS, the Department of Public Works intends to submit a grant application for funding of the projects to support transit oriented development; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:
