WHEREAS, the BSCC announced the CalVIP Cohort 5 grant program notice of funding opportunity on February 14, 2025; and

WHEREAS, the City of Fresno (City) Parks, After School, Recreation and Community Services Department is seeking authority to have the City Manager or Designee apply for and accept funding to fund violence prevention and intervention programming for youth and/or young adults through Camp Fresno, PARCS After School Program, and Midnight programming; and

WHEREAS, the City, if successful, will enter into a grant agreement with the BSCC for the implementation of grant funded programming.

Council authorizes the City Manager or designee to apply for a grant of up to \$3 million from BSCC's CalVIP Cohort 5 grant program to fund violence prevention and intervention programming through Advance Peace, Camp Fresno youth programming, PARCS After School Program, and Midnight programming; and
