

LEASE AMENDMENT NO. 3

AIRPORT LEASE AGREEMENT

Between

CITY OF FRESNO, CALIFORNIA

And

JOHN TOMAINO AN INDIVIDUAL
D.B.A. AMERICAN HELICOPTERS

THIS LEASE AMENDMENT NO. 3 ("Amendment 3") is effective the ___ Day of ___, 2017, by and between the CITY OF FRESNO, CALIFORNIA, a municipal corporation hereinafter referred to as "LESSOR" and John Tomaino, an individual, doing business as American Helicopters, located at 612 West Kearney Avenue, Fresno California 93706, hereinafter referred to as "LESSEE."

RECITALS

WHEREAS, the Parties entered into a Fresno Chandler Executive Airport Lease Agreement dated March 1, 2010 (the "Agreement"), for a paved parcel of land measuring approximately 36,000 square feet, including a 6,560 square foot hangar (Lease Lot No. FBO-6) at the Fresno Chandler Executive Airport; and

WHEREAS, the Parties entered Amendment No. 1, effective March 1, 2013, extending the term of the Agreement to February 28, 2016; and

WHEREAS, the Parties entered Amendment No. 2, effective March 1, 2016, extending the term of the Agreement to February 28, 2019; and

WHEREAS, the Parties now desire with this Amendment No. 3 to increase the size of the Premises and adjust Rent.

AGREEMENT

In consideration of the above, the parties therefore agree as follows:

1. Article I (Grant and Description of Leased Premises), Section A(1), of the Agreement is replaced and re-written as follows:

1. **Premises:** Lessor, in consideration of the rentals, fees, charges, warranties, terms, covenants, conditions and agreements set forth herein, does hereby lease to Lessee and Lessee hereby leases from Lessor that real property located at 612 West Kearney Boulevard at the Airport shown on Exhibit A attached hereto and made a part hereof, comprising a paved parcel of approximately 36,015 square feet including a 6,560 square foot hangar, and Exhibit A1 attached hereto and made a part hereof, comprising a paved parcel of approximately 45,232 square feet including a 7,853 square foot hangar.

2. Article V (Rental, Other Charges, Late Payment, and Security Deposit), Section A(1), of the Agreement is replaced and re-written as follows:

1. **Rent:** Monthly rent in the amount of \$2,893.98 (which is the sum of \$1,038.98 for FBO-6 and surrounding ramp area, plus \$1,855.00 for FBO-9 and surrounding ramp area) shall be due in advance on the first day of each month, and shall be late if not paid by the 10th day of each month.

3. Exhibit A to the Agreement shall be updated with **Exhibit A and Exhibit A1**, attached.
4. Except as expressly provided in this Amendment 3, all other terms and provisions of the Agreement shall continue in full force and effect.

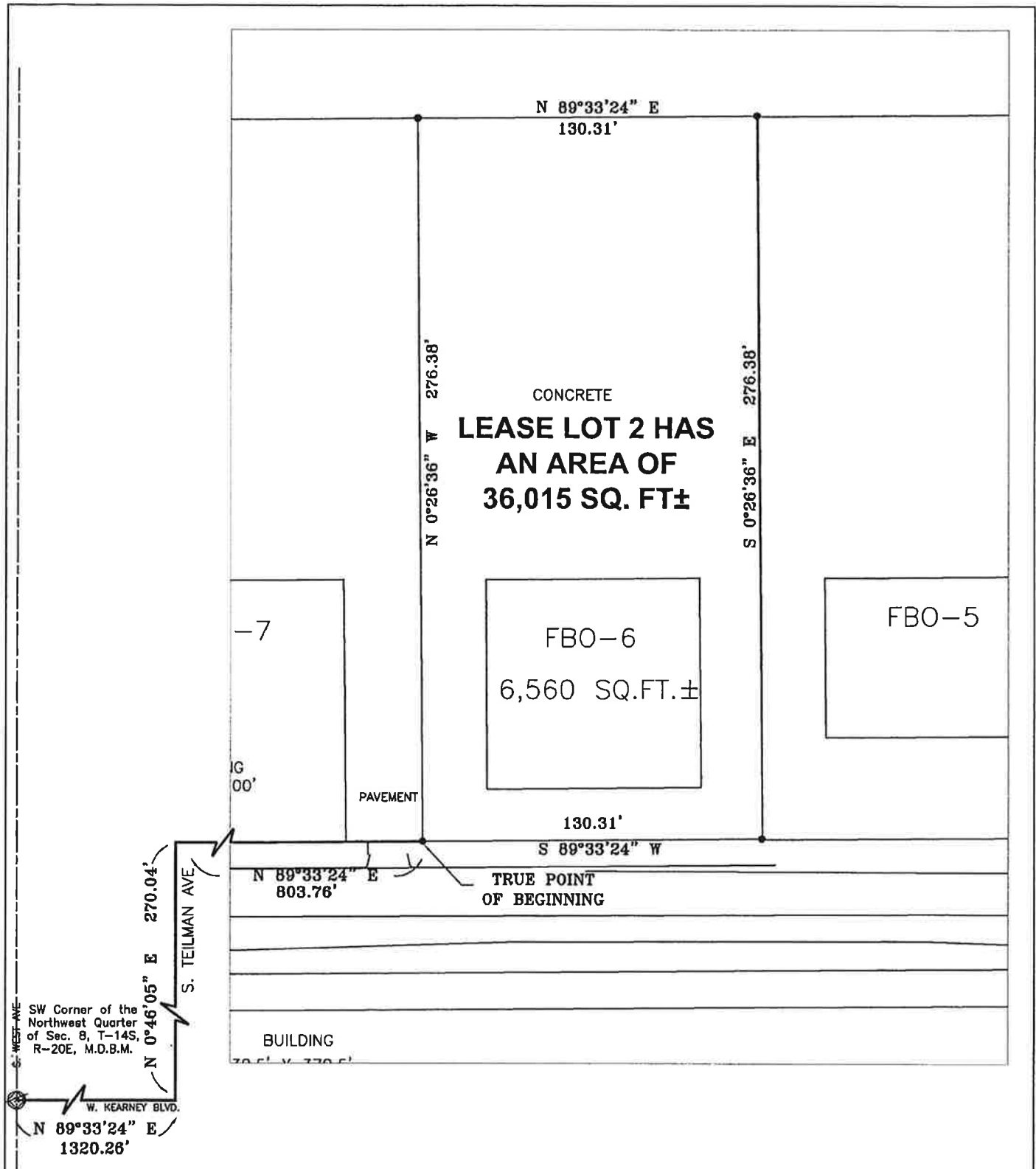

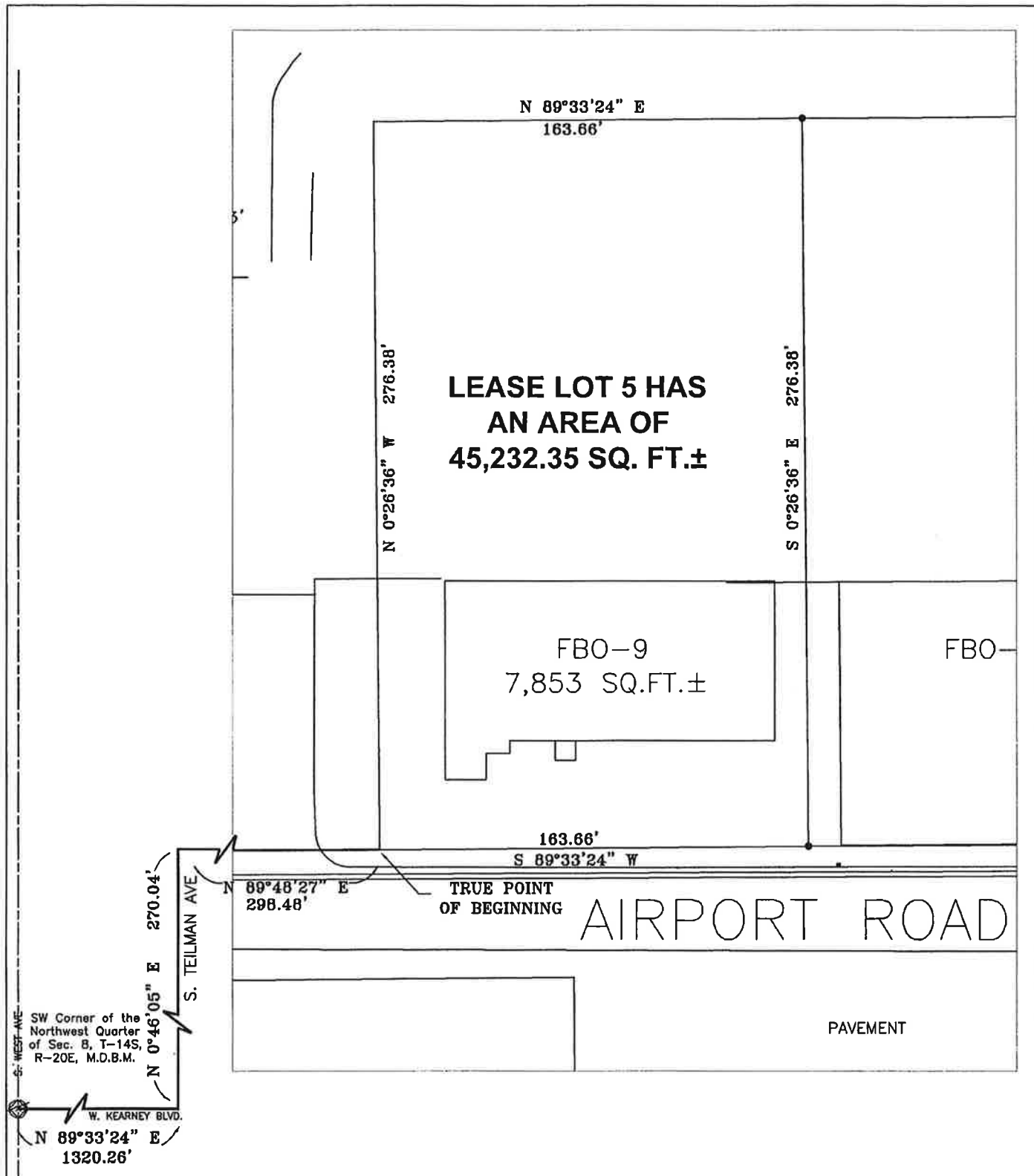
