A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO. CALIFORNIA, AUTHORIZING THE MANAGER OR DESIGNEE TO APPLY AND ACCEPT FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) GRANT FUNDING THROUGH THE CALIFORNIA OFFICE OF **EMERGENCY** SERVICES (CALOES) **FOR** RELATED TO DISASTER REIMBURSEMENT PREPAREDNESS FUNDING

WHEREAS, under the California Disaster Assistance Act, certain financial assistance can be obtained under the Rober T. Stafford Disaster Relief and Emergency Assistance Act of 1988, which amended the Disaster Relief Act of 1974; and

WHEREAS, Federal Emergency Management Agency (FEMA) has made funds available for reimbursement for eligible expenses under various disaster preparedness programs through the California Office of Emergency Services (CalOES); and

WHEREAS, in May 2023, Council approved a resolution identifying designated applicant's agents authorized to apply and execute grant applications on behalf of the City; and

WHEREAS, the City of Fresno (City) wishes to apply for and accept future FEMA funding for prior expenses eligible for disaster preparedness funding.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Approves and supports the application for grant funding from the California Office of Emergency Services (CalOES) for all FEMA grant funds for reimbursement of eligible expenses under various disaster preparedness grant programs.
