# Active Transportation Advisory Committee (ATAC)

Semi-Annual Report (October 2024 – March 2025)

During the period covered by this report, the Active Transportation Advisory Committee conducted 4 meetings, as well as hosted the World Day of Remembrance in November. Members continue to be concerned about the high level of fatalities and collisions in the city of Fresno. In addition, there is significant concern about federal funding for active transportation projects.

Members serve on the Vision Zero Action Plan Task Force and Active Transportation Steering Committee spearheaded by City of Fresno Public Works. The committee provided letters of support for various Public Works grant applications. In addition, members are active in various capacities throughout the community, including serving on the Fresno COG RTP Roundtable, leading bike rides, offering bike repair clinics, connecting with various bike groups and conducting advocacy.

#### 26 February 2025

The ordinance review task force submitted its final report to the committee. Members unanimously approved the report, which recommended a number of changes to the city ordinance code. The committee voted to approve the new ATAC logo, designed by committee member Edna Pedroza. Public works provided updates on projects submitted to Fresno COG for the Regional Transportation Plan, the Vision Zero plan and the Active Transportation Plan update, the collision numbers submitted by the Police Department and the ATAC work plan, as well as on grants applied for.

#### 22 January 2025

Laura Gromis was elected Chair and Sean Zweifler was elected Vice Chair. World Day of Remembrance Task Force provided its final report. Members discussed the Ordinance Review Task Force draft report. Public Works provided updates on the Vision Zero plan and the Active Transportation Plan update, the collision numbers submitted by the Police Department and the ATAC work plan, as well as on grants applied for.

#### 11 December 2024

The ordinance review task force presented its recommended ordinance changes for discussion. A lengthy discussion occurred in which a number of amendments were recommended, which the task force agreed to incorporate. Kiel Lopez-Schmidt, Executive Director of South Tower Community Local Trust discussed bike racks in the Tower District. Public Works provided updates on the Vision Zero Plan and the Active Transportation Plan, the collision numbers submitted by the Police Department, and the ATAC work plan, as well as on grants applied for.
