We are in support of: **Adding Article 17 to Chapter 10 of the Fresno Municipal Code relating to Unlawful Camping. (Citywide)** A series of reforms to help improve homeless impacts in the City. The "Unhealthy and Hazardous Camping Act of 2017" prohibits camping on public and private property (without owner approval and/or permits). This includes camps made of cardboard or tarps, and any other paraphernalia like cooking equipment or facilities. It also calls out behavior like public bathing and going to the bathroom.

As a small non-profit trying to serve the residents of the Central Unified/West of 99 area, we have had to spend thousands to clean and repair the damage from the homeless, that have used the Shaw/Polk Ave area as their new residence.

Some of the issues have included:

- Setting fires on the property, fire damage to buildings & outbuildings
- Breaking water lines, having to have water shut off. (Still seeking means to
- Breaking sprinklers to bath in, resulted in flooded store
- Defecating on the property
- Going through the garbage and leaving a mess. (Tried installing locks on garbage bins, but they cut them off, and broke off lids).
- Dumping garbage on property

The homeless in the area have brought increased crime, destruction of property, residents who will no longer shop at our store thus again reducing our resources to serve. We are excited for solutions for our city, also for positive change in the life of those in homelessness- whether situational, those with mental illness & addiction or through those as urban campers.
