

Please support the West Area Neighborhood Specific Plan.



Dear Council Member Brandon Vang,

My name is Alisia Yang, and I am a proud resident of the West Area and a parent of young children who walk to and from school every day. As a mother, nothing worries me more than knowing my kids and others have to walk on incomplete roads without sidewalks or safe crosswalks near schools like Harvest Elementary, Glacier Middle School and Justin Garza High. Everyday I see students and parents navigate unsafe streets that should have been fixed years ago — and it breaks my heart that something so basic as safe routes to school is still missing in our community. I see it too often and for too long, I have taken photos to prove and share what is taking place in our neighborhoods.

But it's not just about the roads. It's about how forgotten our side of Fresno feels. We don't have enough grocery stores to buy simple necessities like fresh food for our families. We don't have a police station nearby or enough officers on patrol to make us feel truly safe. Many of our streets are cracked and need repaving, our infrastructure is worn down, and access to basic health care — like local clinics and dental offices — is far too limited.

We have beautiful agricultural land here, too — open fields that remind us of Fresno's roots and feed our city. West Area is culturally diverse and there are many Southeast Asian farmers who also contributes. The land deserves to be protected, not pushed aside by unplanned growth. For too long, this side of town has been neglected and left behind. We deserve better. Our families deserve investment, safety, and opportunity.

That's why I am asking you, from the heart, to please vote **yes** on the **West Area**Neighborhood Specific Plan. This plan is not just a document — it is hope. It's a promise that our children will have safe streets to walk on, that families can find healthy food

nearby, that small businesses can grow, and that the West Area will finally feel connected to the rest of Fresno.

For years, residents like me have attended meetings, parent gatherings, and community events to share what we need and what we dream for our neighborhood. We've been patient, persistent, and hopeful. This plan represents our voices — our vision — for a safer, stronger, more vibrant West Fresno.
