AN ORDINANCE OF THE CITY OF FRESNO,  
CALIFORNIA, AMENDING ORDINANCE NO. 2004-88  
RELATING TO REIMBURSEMENT OF EXPENSES FOR  
ELECTED OFFICIALS.

WHEREAS, the Mayor and Councilmembers incur expenses for meals, travel, lodging, and other necessary expenses in the performance of their official duties; and

WHEREAS, public resources may only be used for a public purpose that provides a benefit to the city; and

WHEREAS, Ordinance No. 2004-88 expressly allows for a monthly allowance for vehicle usage and general and miscellaneous expenses in accordance with Exhibit A attached thereto; and

WHEREAS, by this Ordinance, Exhibit A of Ordinance No. 2004-88 shall be amended to allow the election of a flat monthly stipend for vehicle and general and miscellaneous expense allowances.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Exhibit A to Ordinance No. 2004-88 is hereby amended as attached, to implement the option of a flat monthly stipend for elected officials' vehicle and general and miscellaneous expense allowances.

2. The Council hereby finds the amount of the vehicle allowance and miscellaneous expense allowance is a reasonable and representation of the actual

expenses incurred by the Mayor and Councilmembers for such expenses, when taking into consideration an averaging of actual expenses incurred by the Mayor and Councilmembers over a period of several months.
