This new 36-inch plunger valve assembly will replace an existing 18-inch v-port knife gate valve that is insufficient in its capacity to deliver enough water to operate the facility at its current design capacity of 30 MGD.

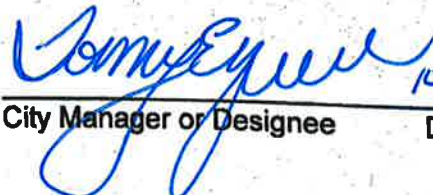

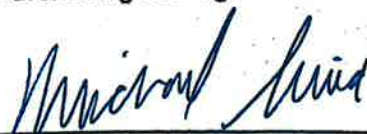
