A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING THE SUBMISSION OF GRANT APPLICATIONS TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATION HIGHWAY SAFETY IMPROVEMENT PROGRAM CYCLE 12 CALL FOR PROJECTS TOTALING UP TO \$10 MILLION IN REQUESTS FOR FUNDING; AND AUTHORIZING THE EXECUTION OF GRANT APPLICATION AND GRANT AGREEMENT DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR DESIGNEE

WHEREAS, the Highway Safety Improvement Program (HSIP) provides grant funds to eligible local agencies for the purpose of achieving a significant reduction in fatalities and serious injuries on all public roads; and

WHEREAS, the California Department of Transportation administers HSIP and has requested applications from eligible agencies for its Cycle 12 call for projects; and

WHEREAS, the City of Fresno is an eligible applicant of the HSIP Cycle 12 Call For Projects; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council approves and supports the application for grant funding from the HSIP for the project(s) and participation therein consistent with constitutional and local law requirements and this resolution.

2. The Council acknowledges that the City has reviewed, understands and to the extent consistent with all constitutional and local law requirements and this resolution
