A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING AN EXCEPTION TO FORMAL BIDDING PROCEDURES AND AWARD OF A SOLE SOURCE PURCHASE AGREEMENT WITH BEAM GLOBAL IN THE AMOUNT OF \$638,209 FOR THE PURCHASE OF SEVEN EV ARC CHARGING SYSTEMS

WHEREAS, the City of Fresno Charter Section 1208(a) requires advertised competitive bidding for the purchase of goods and products involving the expenditure of City monies in excess of \$177,000; and

WHEREAS, City Charter Section 1208(a)(5)(iv) states Section 1208(a) shall not apply when Council determines the work to be done or the goods to be supplied can only be provided by one source, and the purchase is authorized by resolution of the Council containing a declaration of the facts constituting the sole source; and

WHEREAS, the product identified is the EV ARC charging system, for installation at the Municipal Service Center, allowing the City to provide off grid charging for Cityowned electric vehicles; and

WHEREAS, the Department of Public Works applied for and was awarded a grant specifically for the purchase of seven EV ARC charging systems; and

WHEREAS, Beam Global is the sole manufacturer and exclusive provider of the EV ARC charging system; and

WHEREAS, the cost of the procurement of seven EV ARC charging systems is \$638,209.
