On August 22, 2025, Respondents, the City of Fresno (the "City") and the City of Fresno City Council ("City Council"), applied *ex parte* for an Order extending the September 12, 2025, deadline in the Court's July 14, 2025 decision after a hearing on the merits for the City Council to conduct a final hearing concerning the Project to November 11, 2025.

Having considered the Application, the Court finds that the September 12, 2025, deadline should be extended, and GRANTS the Application as follows:

1 The deadlines in the July 14, 2025 ruling for the City Council to conduct a final hearing
2 concerning the Project are extended until November 12, 2025, for the City to complete the tribal
3 consultation process under AB 130.
