BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The RWRf operates 13 mesophilic anaerobic digesters. The digesters range in size from 860,000 to 1,870,000 gallons. The digesters are used in the treatment of the solids generated at the RWRf to eliminate the pathogens and volatile organic compounds. Over the period of approximately seven years, these digesters accumulate debris associated with the treatment (i.e. solids consisting of sludge, sand, plastics, hair, etc.). This Project will remove all the accumulated debris from the digester and allow for the inspection of the interior surfaces for corrosion, wear, and structural stability. The debris will be screened and transported to an appropriate class landfill, and the sludge will be dewatered and processed along with the other dewatered biosolids from the RWRf. The interior of the digester will be pressure washed and then inspected for any structural or coating issues.
