Dear Council President Arias and Councilmembers,

Thank you for the opportunity to comment. We are writing in response to agenda item 1-A ID20-00459, which is considering changes to the Council Rules and Procedure. As an organization working alongside communities who have been historically ignored and continue to be overlooked, we want to ensure a transparent accessible democratic process for all. As such, we have a few concerns and recommendations in response to these modifications for the Council to include.

For section 9(a), we understand and appreciate to take appropriate measures to protect the health, safety, and wellness of Fresno's diverse communities and its residents. Similarly, City Staff and elected officials must recognize the difficulty many populations have accessing and using technology. Thus, we recommend postponing voting on any non-urgent decisions not subject to a statutory deadline where the public may want to participate to wait until the end of a declared emergency to be discussed. For time-sensitive items that must be heard and voted on, translation services will be offered if requested 48 hours in advance, or must be provided for items that may require it. Furthermore, items and materials that will be discussed shall be released and noticed when the agenda is made available.

Second, we recommend modifying the language in 9(d) to limit public comment to two minutes, while adhering to Ca Gov. Code § 54954.3 requiring local legislative bodies to provide "at least twice the allotted time to a member of the public who utilizes a translator". Though this provision is already listed in Rule No. 10 subsection(h), we recommend this to be restated here

to make it unequivocally clear for future Council bodies. Lastly, we defer to our letter from April 1st, 2020 which provided recommendations for public participation during the COVID-19 pandemic. These recommendations include having City Staff and elected officials work with community leaders, community-based organizations, and other entities working directly with disenfranchised populations. And also to provide ample time and a variety of ways for the public to submit comments prior to a meeting, while also facilitating real-time participation.
