As principal at Pinedale Elementary, I would like to express our excitement at the possibility of Valley Health Team opening a clinic near our school site. As you are aware, our school-based health clinic was closed by our district over six years ago. This clinic served our families through providing immunizations, well baby visits, sick visits, and prescriptions, as well as sports physicals and health screenings. Since that time, it has been a struggle for the families in my community to access our only school-based health clinic at Sierra Vista Elementary in downtown Clovis. This is mainly due to transportation and bus routes not being compatible to the location. Many of our families seek treatment through Valley Children's hospital instead. Since Valley Health Team's newest location will be near our school, this will provide many benefits to my families who are seeking medical services.



Greetings City Council Members,

My name is Lori Garcia. I am a former Pinedale resident, and current Board Secretary of the Pinedale Community Association. I am writing today in support of a zoning change that would enable the proposed medical facility to be built in my beloved hometown of Pinedale.

Although I no longer reside in Pinedale, I have 32 years of teaching at Pinedale Elementary School. With that I experience, I can tell you firsthand, there is a critical need for a medical care in the neighborhood.

For various reasons, many students attend school while ill. Often parents lack the means for a full day visit to the doctor's office. Whether it be due to transportation issues, many residents are not able to seek medical facilities outside the community. In addition, parents often do not have the flexibility in their work schedules to take additional time off for these visits. Having a clinic would be a benefit to due to proximity from home or school.

Years ago, when my children were young, I would utilize the Clovis Unified clinic on the Pinedale School campus. I cannot emphasize enough how convenient that was for me, a single working mother, to have access to a local clinic. Since the CUSD clinic moved to a location outside of Pinedale, thousands of children have missed opportunities for health care. With the opening of the new facility, both residents, as well as the Pinedale Staff, would have access to local and convenient health care.
